JURORS' LISTS

Since 1285, a property qualification was required for a person to be eligible to serve on a jury. Succeeding Acts of Parliament have modified the details but the property qualification remained.

By an Act of 1695-6 Parish Constables were required to send to the Clerk of the Peace each year, a list of the persons within the parish who qualified for jury service. To qualify for service, one had to be male, aged between 21 and 70 and hold land (freehold, copyhold or life tenure) worth at least £10 per year.

The annual lists were to be copied into a book and kept as part of the Court records. Further Acts of 1702 and 1729-30 continued the practice. Under the latter Act, long term leaseholders also qualified for jury service, if they occupied property worth £20 per year or more. The same Act empowered any Parish Officer to extract from the parish's assessments to Poor Rates and Land Tax, a list of the names of freeholders, copyholders and others qualified to serve on juries. The list of qualified men, intended to be returned to the Quarter Sessions, then had to be affixed to the door of the Church on two or more Sundays, at least 20 days before Michaelmas.

The earliest surviving return of qualified jurors for High Littleton and Hallatrow is dated September 1796 and contains the names of 14 persons, showing their titles or occupations and abode (Hallatrow or High Littleton). The list was signed by the tithingman and sworn before a Justice of the Peace. Apart from a list for 1810 containing names and occupations, no other such lists survive until 1811, from which date there is an unbroken run of 50 years.

In 1811 the first pre-printed forms were used, which contained columns for names, occupations etc., places of abode, whether freeholder, copyholder or leaseholder, age, and exemptions and observations. After three years of the new forms, High Littleton reverted to hand-written lists of names and occupations!

The Jury Act of 1825 reduced the upper age of eligibility for jury service to 60 and revised the property qualification to freeholds having an annual value of £10 or more, leaseholds of over 21 years worth £20 and rateability of short leasehold property worth £30. New pre-printed forms were introduced with columns for christian and surnames, occupation, parish, and nature of qualification.

Procedures remained broadly similar. Lists were drawn up in early September each year, signed by appropriate parish officers and fixed to the Church door, informing parishioners that all objections to the names would be heard by the Justices at the next Petty Sessions. At the end of the required period, the list was corrected, reformed where necessary and sworn before two Justices of the Peace.

In the lists which follow, the transcriber has placed all the names in alphabetical order, drawn attention to obvious errors in italics, interchanged the order of two columns so that surnames come first and included with ** the names of persons which were struck through on the original. No index has been made.
